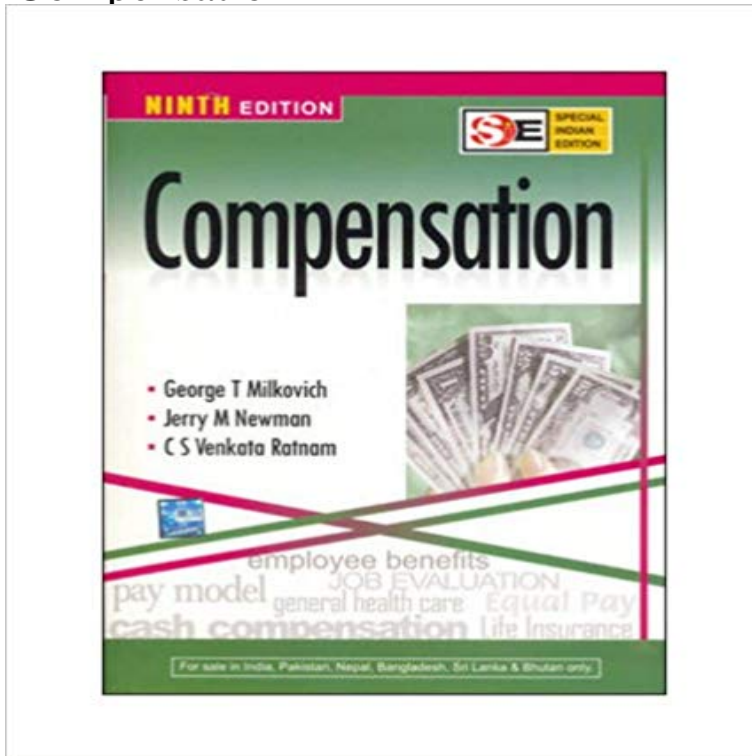


# Compensation
