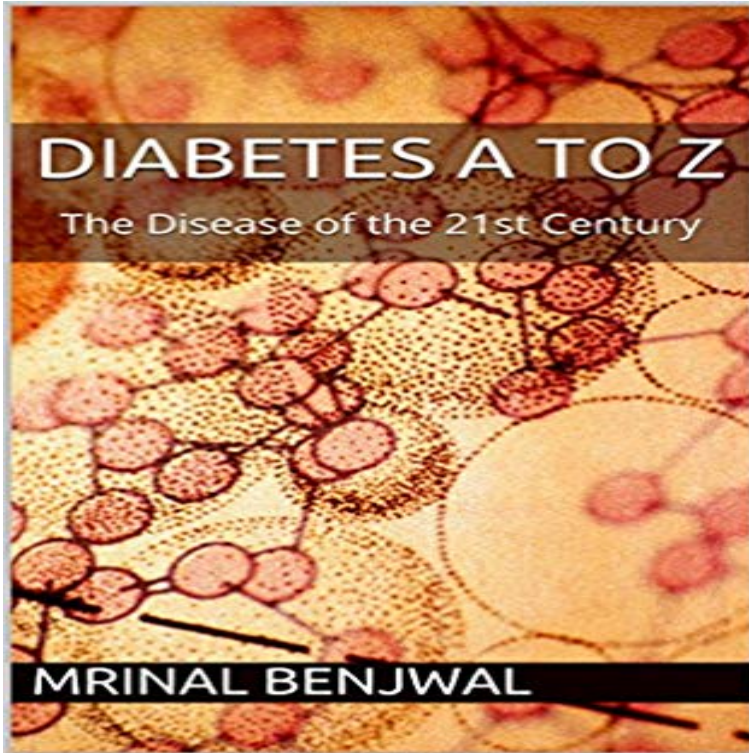


## Diabetes A to Z: The Disease of the 21st Century
