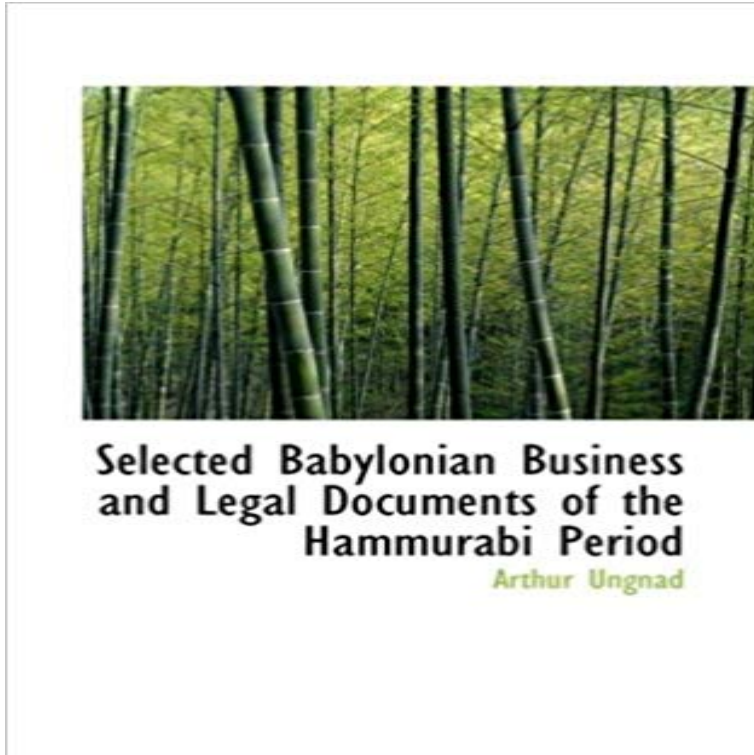


Selected Babylonian Business and Legal Documents of the Hammurabi Period
