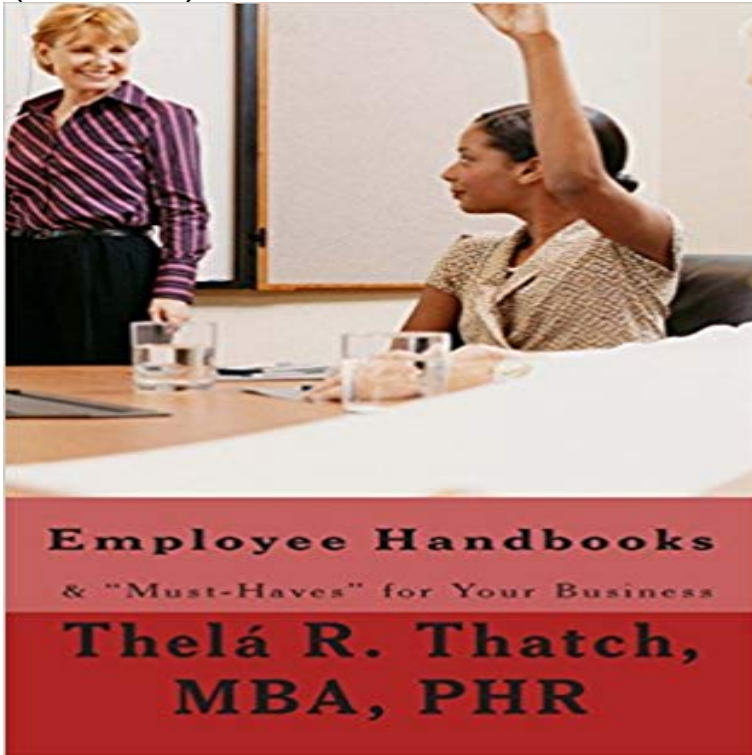


Employee Handbooks & Must-Haves for your business: 2nd Revision (Revised)
